

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to amend Solid Waste Program Revenue Budget in the amount
of \$160,000.00 for FY-2013)

RESOLUTION NO. 13-132

1 **WHEREAS, the Tohono O'odham Legislative Council approved a dedicated account for the Solid**
2 **Waste Management Program Budget 044-13-3525 through Resolution 98-236 and 05-**
3 **558; and**

4 **WHEREAS, the Solid Waste Management Program Revenue Account has a balance sufficient to**
5 **cover the \$160,000.00 increase from fees for services and the sale of materials for**
6 **recycling; and**

7 **WHEREAS, the SWMP prepared a budget in the amount of \$350,000.00 that was approved by**
8 **Legislative Council Resolution #12-232 for the FY2013 budget account 044-13-3525;**
9 **and**

10 **WHEREAS, the SWMP has experienced higher costs for waste disposal, fuel, maintenance and**
11 **repair of equipment and trash bins due to the higher demand for solid waste,**
12 **recycling and heavy equipment services in FY-2013; and**

13 **WHEREAS, the Solid Waste Management Program budget amendment #1 to Budget 044-13-3525**
14 **has been reviewed by the Legislative Agricultural and Natural Resources Committee**
15 **and the Legislative Budget and Finance Committee and recommend its approval and**
16 **adoption.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
18 **the budget amendment #1 to increase the budget from \$350,000.00 to \$510,000.00 for**
19 **an additional \$160,000.00 from deposits of program revenue for the Solid Waste**
20 **Management Program FY-2013 Budget Account 044-13-3525, from October 1, 2012**
21 **through September 30, 2013, in accordance with the budget attached hereto.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the SWMP Revenue**
24 **FY-2013 Budget Account #044-13-3525, provided that any amendments affecting the**
25 **funds or funding level is submitted for further prior approval by the Tohono O'odham**
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
28 **of APRIL, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
29 **AGAINST; -0-NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**
30 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**
