L08AC14165 between the Tohono O'odham Nation and US Bureau of Land Management,
approval of FY-2013 budget and extend the time of the agreement to September 30, 2013)

RESOLUTION NO. 13-133

1 **WHEREAS, the Tohono O'odham Nation received from and approved the US Bureau of Land**
2 **Management Cooperative Agreement #L08AC14165 (formerly AAA080021) to fund**
3 **undocumented migrant and smuggler trash clean-up through December 30, 2012 as**
4 **stated in the Cooperative Agreement; and**

5 **WHEREAS, this Cooperative Agreement amendment #0006 to contract L08AC14165 between the**
6 **Tohono O'odham Nation and the U.S. Bureau of Land Management provides a carry**
7 **forward amount of \$49,161.60 to the Solid Waste Management Program and an**
8 **extension in time to September 30, 2013; and**

9 **WHEREAS, the funds are to be expended for the clean-up of undocumented migrant and smuggler**
10 **waste impacting the Tohono O'odham Nation by the Solid Waste Management**
11 **Program (SWMP); and**

12 **WHEREAS, the SWMP has prepared a budget for the expenditure of these funds; and**

13 **WHEREAS, the budget amendment has been reviewed by the Agricultural and Natural Resources**
14 **Committee and the Budget and Finance Committee of the Legislative Council have**
15 **reviewed this Budget and recommend its approval and adoption.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**
17 **approves the carry forward amount of \$49,161.60, the extension of the agreement to**
18 **September 30, 2013 and the approval of the budget herein attached.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to execute the agreements, expend and**
21 **administer the budget as attached, provided that any amendments affecting the funds**
22 **or funding levels is submitted for further prior approval by the Tohono O'odham**
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
25 **of APRIL, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**
27 **VI, Section 1 (d)(2)(3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**
