

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendment #1 for IGA #DE111026-001 with the Arizona Department of  
Economic Security for the One Stop Division of the Education Department)**

**RESOLUTION NO. 13-134**

1 **WHEREAS, the Arizona Department of Economic Security entered into intergovernmental**  
2 **agreement (IGA) #DE111026-001 with the Tohono O'odham Nation to provide the**  
3 **Nation with funds for specific Workforce Investment Act (WIA) employment and**  
4 **training programs operated by the Education Department's One Stop Division; and**

5 **WHEREAS, the Arizona Department of Economic Security has allocated funds to the Nation for**  
6 **FY2013 in the amount of \$256,254.00 for the period beginning April 1, 2012 to June 30,**  
7 **2014, which has been approved under TOLC Resolution #12-412; and**

8 **WHEREAS, the One Stop Division has seven (7) program budgets for FY13 effective through June**  
9 **30, 2013 and now requests to amend such budgets to reflect the new IDC rate of 18.43%**  
10 **from previous IDC rate of 18.82%; and**

11 **WHEREAS, the following outlines the adjustments to each budget and line item affected, the total**  
12 **budget amount and allocation amount does not change, 1) account #600-13-2011**  
13 **increases line item 7075 Fuel and line item 7110 Communication Expense and**  
14 **decreases line 9000 Indirect Cost Charges, 2) account #600-13-2012 increases line item**  
15 **7665 Client Support and decreases line 9000 Indirect Cost Charges, 3) account #600-**  
16 **13-2013 increases line item 7075 Fuel and decreases line 9000 Indirect Cost Charges,**  
17 **4) account #600-13-2014 increases line item 7665 Client Support and decreases line**  
18 **9000 Indirect Cost Charges, 5) account #600-13-2015 increases line item 7110**  
19 **Communication Expense and decreases line 9000 Indirect Cost Charges, 6) account**  
20 **#600-13-2016 increases line item 7665 Client Support and decreases line 9000 Indirect**  
21 **Cost Charges, 7) account #600-13-2017 increases line item 7665 Client Support and**  
22 **decreases line 9000 Indirect Cost Charges; and**

23 **WHEREAS, the Human Resources Development Committee and the Budget & Finance Committee**  
24 **have reviewed the One Stop Division Budget.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
26 **Amendment #1 between the Arizona Department of Economic Security and the Tohono**  
27 **O'odham Nation substantially in the form attached hereto, and authorizes the**  
28 **Chairman of the Tohono O'odham Nation to execute it.**

1 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council hereby approves

4 **State of Arizona Budget of \$256,254.00 as follows:**

- 7 **2. Account #600-13-2012 increases line item 7665 Client Support and decrease line**

- 9 **3. Account #600-13-2013 increases line item 7075 Fuel and decrease line 9000 Indirect**  
10 **Cost Charges.**
- 11 **4. Account #600-13-2014 increases line item 7665 Client Support and decrease line**  
12 **9000 Indirect Cost Charges.**
- 13 **5. Account #600-13-2015 increase line item 7110 Communication Expense and**  
14 **decrease line 9000 Indirect Cost Charges.**
- 15 **6. Account #600-13-2016 increases line item 7665 Client Support and decrease line**  
16 **9000 Indirect Cost Charges.**
- 17 **7. Account #600-13-2017 increases line item 7665 Client Support and decrease line**  
18 **9000 Indirect Cost Charges.**

19 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council authorizes the Chairperson  
20 **and any designated official to expend and administer the budget as attached, provided**  
21 **that any amendment affecting the funds or funding level shall be submitted for**  
22 **further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
24 **of APRIL, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
25 **AGAINST; -0-NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**  
26 **VI, Section 1 (d)(3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**
