**RESOLUTION NO. 13-137**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws and**  
2 **ordinances governing the enrollment and adoption of members (Article II, Sections**  
3 **1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation);**  
4 **and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the Enrollment**  
6 **Committee is responsible for reviewing enrollment applications and making**  
7 **recommendations to the Legislative Council regarding the eligibility of applicants**  
8 **(Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**  
10 **applicants for membership contain misspellings in the names of applicants; or**  
11 **incorrect roll numbers; and**

12 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 55-81, 74-81, 94-**  
13 **109, 94-154, 94-262, 96-182, 97-256, 99-004, 2000-176, 01-449, 02-042, 04-109 and 05-114**  
14 **be amended to reflect the correct name spelling or roll numbers for the individuals**  
15 **identified in the Amending Enrollment Resolution List May 2013, which is**  
16 **incorporated by this reference; and**

17 **WHEREAS, the Enrollment Program has further determined that a member was erroneously**  
18 **approved twice for membership (member was originally approved by Resolution No.**  
19 **97-256); and**

20 **WHEREAS, the Enrollment Program discovered that this same member was approved a second**  
21 **time in Resolution Nos. 92-450; and**

22 **WHEREAS, the Enrollment Program therefore recommends that Resolution No. 92-450 be**  
23 **amended to delete the member identified in the Amending Enrollment Resolution List**  
24 **May 2013; and**

25 **WHEREAS, the member who was originally approved in Resolution No. 97-256 will retain the roll**  
26 **number and approval date identified in that original resolution.**

27 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
28 **Nos. 55-81, 74-81, 94-109, 94-154, 94-262, 96-182, 97-256, 99-004, 2000-176, 01-449, 02-**  
29 **042, 04-109 and 05-114 are amended upon the effective date of those resolutions to**

8 of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;  
9 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article II,  
10 Section 1 and Section 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham  
11 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
12 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
13 of the Act of June 18, 1934 (48 Stat. 984).
