(Amending Resolution No. 12-474 "Approving the Monthly Age 18 Report for December 2012
of Tohono O'odham Eligible Minor Members and Authorizing Distribution of the Per

RESOLUTION NO. 13-140

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the "Tohono**
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per**
3 **capita payments to the Nation's members provided that sufficient gaming revenues**
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**
7 **distribution payments in accordance with the Initiative (Legislative Council**
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Trust Agreement with Wells Fargo Bank requires that a listing of all minor**
10 **beneficiaries turning 18 that month be presented to the Tohono O'odham Legislative**
11 **Council to obtain approval to distribute the trust funds to these eligible minor**
12 **members as they are no longer restricted beneficiaries; and**

13 **WHEREAS, the Tohono O'odham Legislative Council approved the minors identified on the**
14 **Monthly Age 18 Report for December 2012 who reached the age of 18 and are no longer**
15 **restricted from receiving their per capita payments in Resolution No. 12-474; and**

16 **WHEREAS, the Nation's Enrollment Office has identified an incorrect name on a member on the**
17 **Monthly Age 18 Report December 2012; and**

18 **WHEREAS, the Nation's Enrollment Office recommends that the name for the member be**
19 **amended on the Monthly Age 18 Report December 2012.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**
21 **Resolution No. 12-474, Approving the Monthly Age 18 Report for December 2012 of**
22 **Tohono O'odham Eligible Minor Members and Authorizing Distribution of the Per**
23 **Capita Payments and Interest Held in Trust on Their Behalf by Wells Fargo Bank, to**
24 **reflect the correct name of member in accordance with the Monthly Age 18 Report**
25 **Amendment December 2012.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
27 **of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
28 **[01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,**
29 **Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
30 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
31 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
