1 **WHEREAS, the Tohono O'odham Nation Cultural Center & Museum has applied for and received**  
2 **an Institute of Museum and Library Services (IMLS) grant in the amount of \$49,330.00**  
3 **(award #MN-03-12-0017-12) for the Tohono O'odham Nation's Himdag Ki: supporting**  
4 **a professional development measure for two Museum Trainees as part of the**  
5 **Museum's Collections Preparedness Project; and**

6 **WHEREAS, the Cultural Center & Museum has prepared a FY '13 budget to expend these funds;**  
7 **and**

8 **WHEREAS, the Cultural Preservation Committee and the Budget and Finance Committee of the**  
9 **Legislative Council have reviewed this Budget and recommend its approval and**  
10 **adoption.**


11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
12 **and accepts the Native American/Hawaiian Museum Service grant in the amount of**  
13 **\$49,330.00 for Himdag Ki: for the purposes of the Collections Preparedness Project.**

14 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council does approve the FY 2013**  
15 **Native American/Hawaiian Museum Service budget in the amount of \$49,330.00**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **Chairperson and any designated official to execute the agreements, expend and**  
18 **administer the budget as attached, provided that any amendments affecting the funds**  
19 **or funding levels is submitted for further prior approval by the Tohono O'odham**  
20 **Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
22 **of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,594.30 FOR; -0- AGAINST;**  
23 **-0- NOT VOTING; and 186.30 [06] ABSENT, pursuant to the powers vested in the Council by Article**  
24 **VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
25 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
26 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
