

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Memorandum of Understanding between the Native American
Targeted Investigation of Violent Enterprise and the Tohono O'odham Nation)**

RESOLUTION NO. 13-145

1 **WHEREAS, the Tohono O'odham Nation Police Department seeks to enter into a Memorandum**
2 **of Understanding (MOU) with the Native American Targeted Investigation of Violent**
3 **Enterprise (NATIVE) Task Force to combat smuggling operations of individuals and**
4 **organizations; and**

5 **WHEREAS, the NATIVE Task Force initiative focus is to reduce drug trafficking and related crimes**
6 **by dismantling and disrupting drug smuggling operations; and**

7 **WHEREAS, this MOU has been reviewed by the Domestic Affairs Committee which recommends**
8 **Legislative Council approval.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
10 **approves the MOU with the Native American Targeted Investigation of Violent**
11 **Enterprises Task Force substantially in the form attached hereto, and authorizes the**
12 **Chairman of the Nation to execute the MOU.**

13 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it authorizes the**
14 **Chairman and the Nation's Police Department to fully implement the MOU provided**
15 **that any amendments shall be submitted for full approval by the Tohono O'odham**
16 **Legislative Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
18 **of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
19 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,**
20 **Section 1 (f) and 1 (I) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
21 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**
