1 **WHEREAS, the Low Income Home Energy Assistance Program (LIHEAP) services are provided**
2 **through the Arizona Department of Economic Security, Intergovernmental**
3 **Agreement, Contract No. DE111074001; and**

4 **WHEREAS, Amendment No. 5 to the Intergovernmental Agreement has been received, deleting**
5 **and replacing: Terms and Conditions, Background Checks for Employment through**
6 **the Central Registry, section 16.0; and**

7 **WHEREAS, Amendment No. 5 has been reviewed by the Executive Branch Attorney and the**
8 **Nation's Attorney General's office; and**

9 **WHEREAS, the Health and Human Services committee and the Domestic Affairs committee have**
10 **reviewed this contract amendment and recommend its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
12 **Amendment No. 5 to the Intergovernmental Agreement for the FY2013 LIHEAP**
13 **program for the period beginning July 01, 2012 to June 30, 2013.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the**
15 **Chairperson of the Nation to execute Amendment No. 5 substantially in the form**
16 **attached hereto; provided however that any amendments affecting the contract**
17 **amount shall be submitted for further prior approval by the Tohono O'odham**
18 **Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
20 **of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
21 **[01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,**
22 **Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
