

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Setting May 20-24, 2013 Special Session to Address the Nation's FY 2014 Budgets)

LEGISLATIVE ORDER NO. 13-148

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to  
2 regulate all meetings of the Tohono O'odham Council, standing committees, boards  
3 and special committees." (Constitution of the Tohono O'odham Nation, Article VI,  
4 Section 1(a)); and

5 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with  
6 the authority to "by majority vote, call for a special session" (Legislative Rules of the  
7 Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 WHEREAS, the Budget and Finance Committee has requested a May 20-24, 2013 special session  
9 to address the Nation's FY 2014 budgets.

10 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a May  
11 20-24, 2013 special session to address the Nation's FY 2014 budgets.

12 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> day of  
13 MAY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;  
14 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,  
15 Section 1 (a) and 1(d) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
16 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
18 Stat. 984).
