LEGISLATIVE ORDER NO. 13-150

5	WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with						
6	the authority to "by majority vote, call for a special session" (Legislative Rules of the						
7	Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and						
8	WHEREAS, the Housing Committee requests a special session on May 17, 2013 to address the						
9	Nation's proposed revised Building Codes.						
10	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a						
11	special session on May 17, 2013 to address the Nation's proposed revised Building						
12	Codes.
