

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Legislative Rules of the Tohono O'odham Legislative Council)**

**DEFEATED
LEGISLATIVE ORDER NO. 13-151**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative**
2 **Council with the power to establish rules and procedures to regulate all meetings of**
3 **the Council and its standing committees (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 1 (a)); and**

5 **WHEREAS, the Legislative Council has exercised this power by adopting and amending the**
6 **Legislative Rules of the Tohono O'odham Legislative Council ("Legislative Rules"),**
7 **which include the process for submitting items to be placed on the Council's agendas;**
8 **and**

9 **WHEREAS, it is in the Legislative Council's best interest to amend Legislative Rules Article III, in**
10 **accordance with the attached Legislative Rules amendments as dated for reference**
11 **May 2013 in order to ensure that appointments of treasurer and other officers and**
12 **heads of all governmental departments are appointed in a timely manner, to make the**
13 **Council's process for reviewing appointments more uniform, and to ensure Council**
14 **has adequate information to assess an appointee's qualifications and suitability for**
15 **appointment; and**

16 **WHEREAS, the amendments also would ensure that radio broadcasts of Council sessions will**
17 **continues to provide the public with access to public policy debates and legislative**
18 **decisions without being misused to announce or promote the candidacy of any person**
19 **running for an elected office of the Nation.**

20 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby adopts**
21 **the Legislative Rules amendments as dated for reference May 2013, which shall not**
22 **apply to appointments previously approved by the Legislative Council.**

23 **The foregoing Resolution was defeated by the Tohono O'odham Legislative Council on the 08TH Day**
24 **of MAY, 2013 at a meeting at which a quorum was present with a vote of 767.85 FOR; 2,012.75**
25 **AGAINST; 0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article**
26 **VI, Section 1(a); Article VII, Section 2(e) of the Constitution of the Tohono O'odham Nation, adopted**
27 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**


