5	WHEREAS, in 1988 the Legislative Council adopted a Plan of Operation for the Budget and Finance
6	Committee pursuant to Resolution No. 83-88, as amended by Resolution No. 06-549,
7	"Amending Budget and Finance Committee Plan of Operation"; and
8	WHEREAS, the Rules Committee in coordination with the Budget and Finance Committee has
9	recently drafted amendments to the Plan of Operation for the Budget and Finance
10	Committee to add two additional members and to incorporate provisions that appear
11	in standard plans for other Legislative Council committees; and
12	WHEREAS, because the Budget and Finance Committee's amended Planof Operation will replace
13	the plan adopted pursuant to Resolution No. 06-549, it is necessary to repeal
14	Resolution No. 06-549.
15	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
16	repeals Resolution No. 06-549 and the Budget and Finance Committee Plan of
17	Operation.
18	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that this resolution shall
19	become effective during the June 2013 general session upon the Legislative Council's
20	vote to issue certificates of election in accordance with Section 6.N. of Article VII of the
21	Uniform Election Ordinance.
