15	items to cover anticipated costs.

17	2012 surplus funds in the amount of \$12,521.55 to their FY 2013 budget increasing FY
18	2013 budget from \$35,555.31 to \$48,076.86 is hereby approved.
19	BE IT FURTHER RESOLVED that the TOKA 50/50 District Challenge match in the amount of
20	\$100,000.00 is hereby approved.
