

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Chukut Kuk District FY 2013 Budget Amendment No. 3)

RESOLUTION NO. 13-159

1 **WHEREAS, Chukut Kuk District FY 2013 Budget Amendment No. 3 was approved by Chukut Kuk**
2 **District Council Resolution No. 2013-47; and**

3 **WHEREAS, the Chukut Kuk District Council also approved FY 2013 budget amendment for Vamori**
4 **Community (Chukut Kuk District Resolution No. 2013-30); and**

5 **WHEREAS, the Chukut Kuk District Council approved the TOKA 50/50 District Challenge (Chukut**
6 **Kuk District Resolution No. 2013-41) attached hereto and incorporated in the FY 2013**
7 **Chukut Kuk District Budget; and**

8 **WHEREAS, Chukut Kuk District FY 2013 Budget Amendment No. 3 has been presented to the**
9 **Legislative Council Budget & Finance Committee for review.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
11 **Chukut Kuk District FY 2013 Budget Amendment No. 3 attached hereto and**
12 **incorporated herein, increasing the FY 2013 budget from \$1,781,756.50 to**
13 **\$2,008,904.59.**

14 **BE IT FURTHER RESOLVED that savings in the amount of \$214,626.54 will be added to various line**
15 **items to cover anticipated costs.**

16 **BE IT FURTHER RESOLVED that the Vamori community FY 2013 budget amendment adding FY**
17 **2012 surplus funds in the amount of \$12,521.55 to their FY 2013 budget increasing FY**
18 **2013 budget from \$35,555.31 to \$48,076.86 is hereby approved.**

19 **BE IT FURTHER RESOLVED that the TOKA 50/50 District Challenge match in the amount of**
20 **\$100,000.00 is hereby approved.**

21 **BE IT FINALLY RESOLVED that any amendments affecting the funding level of the Chukut Kuk**
22 **District FY 2013 budget shall be submitted to the Tohono O'odham Legislative Council**
23 **for prior approval.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
25 **of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
27 **Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
28 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
29 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**






