

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Representative Grace Manuel to the Administration for Children and
Families Tribal Advisory Committee)**

RESOLUTION NO. 13-161

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**
2 **authority "to promote, protect and provide for public health, peace, morals, education**
3 **and general welfare of the Tohono O'odham Nation and its members. . ." and with the**
4 **authority to "consult, negotiate and conclude agreements and contracts on behalf of**
5 **the Tohono O'odham Nation with Federal, State and local governments and other**
6 **Indian tribes. . .within the authority of the Tohono O'odham Council." (Constitution,**
7 **Article VI, Section 1(c)(2) and Section 1(f)); and**

8 **WHEREAS, one of the main priorities of the Legislative Council is to foster, support, and**
9 **encourage the health, safety, and general well-being of the Nation's children and**
10 **youth; and**

11 **WHEREAS, the Administration for Children and Families ("ACF") provides a number of grants,**
12 **programs, and services, including but not limited to domestic violence prevention,**
13 **child support enforcement, Head Start, child care, and other resources; and**

14 **WHEREAS, the ACF is seeking nominations for its new Tribal Advisory Committee "to assist and**
15 **provide advice to the Assistant Secretary for Children and Families. . ." (March 8, 2013**
16 **ACF letter); and**

17 **WHEREAS, it is in the best interest of the Tohono O'odham Nation and its members to nominate**
18 **a Legislative Council Health and Human Services Committee member to the ACF Tribal**
19 **Advisory Committee; and**

20 **WHEREAS, the Health and Human Services Committee recommends nominating Rep. Grace**
21 **Manuel to the ACF Tribal Advisory Committee.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it nominates**
23 **Rep. Grace Manuel to the ACF Tribal Advisory Committee, provided that Rep. Grace**
24 **Manuel's nomination to the ACF Tribal Advisory Committee shall expire immediately**
25 **if she is no longer a member of the Health and Human Services Committee.**

6 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
7 Stat. 984).
