4		authority to "consult, negotiate and conclude agreements and contracts on behalf of
		the Tohono O'odham Nation with Federal, State and local governments and other

6		Indian tribeswithin the authority of the Tohono O'odham Council." (Constitution,
7		Article VI, Section 1(c)(2) and Section 1(f)); and
8	WHEREAS,	one of the main priorities of the Legislative Council is to foster, support, and
9		encourage the health, safety, and general well-being of the Nation's children and
10		youth; and
11	WHEREAS,	the Administration for Children and Families ("ACF") provides a number of grants,
12		programs, and services, including but not limited to domestic violence prevention,
13		child support enforcement, Head Start, child care, and other resources; and
14	WHEREAS,	the ACF is seeking nominations for its new Tribal Advisory Committee "to assist and
15		provide advice to the Assistant Secretary for Children and Families" (March 8, 2013
16		ACF letter); and
17	WHEREAS,	it is in the best interest of the Tohono O'odham Nation and its members to nominate
18		a Legislative Council Health and Human Services Committee member to the ACF Tribal
19		Advisory Committee; and
20	WHEREAS,	the Health and Human Services Committee recommends nominating Rep. Grace
21		Manuel to the ACF Tribal Advisory Committee.
22	NOW, THER	REFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it nominates
23		Rep. Grace Manuel to the ACF Tribal Advisory Committee, provided that Rep. Grace
24		Manuel's nomination to the ACF Tribal Advisory Committee shall expire immediately
25		if she is no longer a member of the Health and Human Services Committee.
