1	WHEREAS, the Legislative Council is vested with the power to "enact laws and ordinances
2	governing the relinquishment and loss of membership" (Constitution of the
3	Tohono O'odham Nation, Article VI, Section 1(h)); and
4	WHEREAS, Article IX, Section 2 of the Enrollment Ordinance, Ordinance No. 05-81, as amended,
5	provides for the loss of membership in the Tohono O'odham Nation on grounds of dual
6	enrollment or when enrollment was based upon incorrect or omitted information,
7	including a process for appealing a Legislative Council determination for loss of
8	membership to the Tohono O'odham Courts; and
9	WHEREAS, the Rules Committee has developed amendments to Article IX of the Enrollment
10	Ordinance to clarify the process for providing notice of revocation hearings ("May 2013
11	Enrollment Ordinance Amendments"); and
12	WHEREAS, the Rules Committee recommends that the May 2013 Enrollment Ordinance
13	Amendments, which are incorporated by this reference, be adopted.
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby adopts
15	the May 2013 Enrollment Ordinance Amendments.
16	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $17^{TH}$ Day
17	of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,553.90 FOR; <u>-0-</u> AGAINST;

19	VI, Section 1( <u>h)</u> and Article II of the Constitution of the Tohono O'odham Nation, adopted by the
20	Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
21	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
22	18, 1934 (48 Stat. 984).
