RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Amending Uniform Election Ordinance Article XI)

RESOLUTION NO. 13-171

1	WHEREAS, the Legislative Council is vested with "all of the legislative powers vested in the Tohono
2	O'odham Nation," the power to appoint Judicial Court judges, to protect and promote
3	individual rights, and to enact laws providing for the administration of justice
4	(Constitution of the Tohono O'odham Nation, Article III, Article V, Section 1; Article VI,
5	Section 1; and Article VIII); and
6	WHEREAS, the Nation's Constitution does not define a process for judges to resign from office;
7	and
8	WHEREAS, in order to fully exercise its right to self-determination as a sovereign tribal
9	government, to protect and maintain individual rights, and to provide for the
.0	administration of justice, it is in the Nation's best interest to amend Article XI, Section
.1	3 of the Uniform Election Ordinance to provide a process for recognizing judicial
.2	resignations.
3	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends
4	Uniform Election Ordinance Article XI, Section 3, to add subsection 10 as follows:
5	Section 3 <u>Resignation</u>
6	Resignation shall be in writing, and made as follows:
l 7	••••
18	10. By a judge to the Legislative Council chairperson; provided that a full-time judge
19	who fails to appear for five consecutive working days without written notice to
20	the chief judge shall be deemed to have resigned unconditionally if the chief
21	judge delivers written notice of the resignation to the Legislative Council
22	chairperson, at which time the resigning judge's office will be vacant.
23	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $20^{ ext{TH}}$ Day
24 25	of <u>MAY, 2013</u> at a meeting at which a quorum was present with a vote of <u>2,780.60</u> FOR; <u>-0-</u> AGAINST; -0-NOT VOTING; and <u>-0-</u> ABSENT, pursuant to the powers vested in the Council by Article III; Article
26	V, Section 1; Article VI, Section 1 and Article VIII of the Constitution of the Tohono O'odham Nation,
27	adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
28	Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
29	of June 18, 1934 (48 Stat. 984).
