(Approval of the Emergency Funding Allocation from Indian Health Services carry
forward budget for FY 13 of \$42,423.31 for addressing the Rocky Mountain
Spotted Fever (RMSF))

RESOLUTION NO. 13-173

1 **WHEREAS, the Tohono O'odham Nation declared an outbreak of the Rocky Mountain Spotted**
2 **Fever (RMSF) on the Tohono O'odham Nation by Resolution No. 11-555; and**

3 **WHEREAS, in Resolution #11-555, the Tohono O'odham Nation formally requested the assistance**
4 **of the Indian Health Services, the Center for Disease Control (CDC), the Arizona**
5 **Department of Health Services and Pima County Health Department; and**

6 **WHEREAS, emergency funding was requested from Indian Health Services; and**

7 **WHEREAS, funds were received from Indian Health Services in the amount of \$200,000.00 assign**
8 **to Tohono O'odham Nation (Management of Health (MOH)) contract**
9 **HHS1249200400001C and the indirect cost has been waived due to direct emergency;**
10 **and**

11 **WHEREAS, a carry forward FY13 budget in the amount of \$42,423.31 has been developed in**
12 **conjunction with the Tohono O'odham Nation Police Department and Natural**
13 **Resource Department; and**

14 **WHEREAS, RMSF Emergency Funding budget has been reviewed by the Health and Human**
15 **Services and Budget & Finance Committees of the Legislative Council and recommend**
16 **the approval and adoption.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
18 **approves:**

- 19 **1. A carry forward FY13 budget of \$42,423.31 to continue to address the Rocky**
20 **Mountain Spotted Fever on the Tohono O'odham Nation.**
- 21 **2. The Tohono O'odham Legislative Council waives the indirect cost for the budget**
22 **as funding is being received directly from Indian Health Services Emergency Fund.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the budget as**
25 **attached, provided that any Amendments affecting the funds or funding level is**
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


