**RESOLUTION NO. 13-174**

1 **WHEREAS, the Tohono O'odham Nation is concerned with the health, welfare and safety of its**  
2 **members who reside on or near the Tohono O'odham Nation Reservation, including**  
3 **the O'odham in Mexico; and**

4 **WHEREAS, Public Health Preparedness and Response for Bioterrorism is within the charter of the**  
5 **Tohono O'odham Department of Health and Human Services, Division of Community**  
6 **Health Services; and**

7 **WHEREAS, the cost reimbursement IGA #HG954111 with the Arizona Department of Health**  
8 **Services for period 08/09/08 – 08/08/13 approved via TOLC Resolution No. 09-123 has**  
9 **been replaced with a fixed price contract IGA #ADHS11-005790 with a project period**  
10 **of 09/1/10 - 08/31/15 approved in TOLC resolution 10-478; and**

11 **WHEREAS, the Center for Disease Control award stipulates a 10% match requirement which will**  
12 **be met through cost share of the Public Health Preparedness Coordinator salary with**  
13 **Community Health Services; and**

14 **WHEREAS, ADHS has issued the FY13 award amount of \$34,383.06 approved by TOLC resolution**  
15 **12-491; and**

16 **WHEREAS, the Grants and Contract Office has identified FY12 unobligated balance of \$64,645.44**  
17 **to which the FY13 award in the amount of \$34,383.06 will be combined resulting in an**  
18 **amendment FY13 budget for a total amount of \$99,028.50; and**

19 **WHEREAS, the FY13 BT budget is amended to increase Salary and Fringe line items, 7000**  
20 **Supplies-Office, 7500 Supplies-Office Equipment, 7345 Consultants, 9000 Indirect Cost**  
21 **Charges; decrease line items 7300 Advertising, 6510 Lodging, 6530 Transportation,**  
22 **7340 Public Relations and add line items 7010 Program Supplies and 7355**  
23 **Professional Services; and**

24 **WHEREAS, the Health and Human Services Committee and Budget and Finance Committee have**  
25 **reviewed the FY13 BT budget amendment and recommend its approval and adoption.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 27 **1. Approves the FY13 BT budget amendment #1 to combine the FY13 award amount**  
28 **of \$34,383.06 to the FY12 carry forward \$64,645.44 for a budget total to \$99,028.50.**

12 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


