

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of Amendment #1 to the General Assistance Program Grant)**

**RESOLUTION NO. 13-177**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY2013 General Assistance**  
2 **Program (GAP) Grant Budget on June 28, 2012 by Resolution No. 12-241; and**

3 **WHEREAS, the General Assistance Program Grant extends from October 1, 2009 through**  
4 **September 30, 2013; and**

5 **WHEREAS, the U.S. Environmental Protection Agency has identified that the FY2013 budget of**  
6 **\$364,925 is comprised of \$265,000 of funds and \$99,925.00 of new funds awarded; and**

7 **WHEREAS, the Tohono O'odham Environmental Protection Office (EPO) requests to amend the**  
8 **FY2013 Budget to include the funds of \$265,000 and new funding of \$99,925.00**  
9 **amounts as identified; and**

10 **WHEREAS, the FY2013 budget will increase from \$335,867.00 to \$364,925.00; and**

11 **WHEREAS, the following line items will be increased: 6510 Lodging, 6520 Per Diem, 7005 Supplies-**  
12 **Office Equipment, 7355 Professional Services, and 7410 RM Vehicles; and**

13 **WHEREAS, the following line items will be decreased: 6500 Training Fees and Registration, 6540**  
14 **Mileage POV, 7000 Supplies-Office, 7075 Fuel, 7110 Communication Expense and 7340**  
15 **Public Relations; and**

16 **WHEREAS, to add new line item: 7500 Major Capital; and**

17 **WHEREAS, the Domestic Affairs Committee and Budget & Finance Committee of the Legislative**  
18 **Council has reviewed Budget Amendment #1 and recommend its approval and**  
19 **adoption.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
21 **Amendment #1 in accordance with the budget attached hereto.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
23 **Chairperson and any designated official to expend and administer the budget, as**  
24 **attached, provided that any amendments affecting the funds or funding levels of the**  
25 **budget shall be submitted for further prior approval by the Tohono O'odham**  
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
28 **of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
29 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI,**  
30 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
31 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
32 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
