

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of FY 2012 Carry Forward Funds and no-cost extension of the US Department of Homeland Security, Federal Emergency Management Agency, FY2010 Emergency Operations Center Grant, Grant No. 2010-EO-MX-0013 for \$500,000.00)**

**RESOLUTION NO. 13-182**

- 1 **WHEREAS, the United States Department of Homeland Security (DHS), Federal Emergency**  
2 **Management Agency (FEMA) has distributed grants to states to fund for purchases that**  
3 **provide public safety services within their respective jurisdictions; and**
- 4 **WHEREAS, the Tohono O'odham Nation submitted an application to FEMA for direct funding**  
5 **under the FY2010 Emergency Operations Center (EOC) Grant Program to enhance**  
6 **emergency management and preparedness capabilities by supporting flexible,**  
7 **sustainable, secure strategically located, and fully inter-operative EOC's with a focus**  
8 **on addressing identified deficiencies and needs; and**
- 9 **WHEREAS, the United States Department of Homeland Security, Federal Emergency Management**  
10 **Agency has awarded the Tohono O'odham Nation under FY2010 Emergency Operations**  
11 **Center (EOC) Grant Program, Grant No. 2010-EO-MX-0013 in the amount of \$500,000;**  
12 **and**
- 13 **WHEREAS, Award No. 2010-EO-MX-0013 requires a twenty-five (25%) percent match in the amount**  
14 **of \$166,667.00; and**
- 15 **WHEREAS, the Tohono O'odham Law Nation Enforcement Account #100-13-5001 has obligated**  
16 **funds in the amount of \$166,667.00 to meet the twenty-five (25%) percent match; and**
- 17 **WHEREAS, the Tohono O'odham Nation has requested and was approved for a six (6) month no-**  
18 **cost extension, revising project end date from May 31, 2013 to November 30, 2013; and**
- 19 **WHEREAS, FY2010 Emergency Operations Center Grant Program No. 2010-EO-MX-0013 has been**  
20 **reviewed by the Budget Office, Office of Grants & Contracts, Executive Office, Domestic**  
21 **Affairs Committee and Budget & Finance Committee, of which all recommend**  
22 **acceptance of the grant award by the Legislative Council.**
- 23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
24 **carry forward funds of the 2010 EOC Grant Program No. 2010-EO-MX-0013 on a**  
25 **reimbursement basis from the Tohono O'odham Nation General Fund.**
- 26 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves and authorizes**  
27 **the Office of Emergency Management to expend the carry forward funds from FY 2012**  
28 **of the FY2010 EOC Grant Program for FY 2013 and any remaining funds to be carried**



2 01, 2010 to November 31, 2013.


3 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
4 Nation's Officials to wit: the Chairman, Chairperson and any designed official are  
5 authorized to negotiate and execute the grant, provided however, that any  
6 amendments affecting the funding or funding levels of the grant shall be submitted  
7 for further prior approval.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day  
9 of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;  
10 [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,  
11 Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham  
12 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
13 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


