T	WHEREAS, the Constitution of the Tohono O'odnam Nation vests the Tohono O'odnam Legislative						
2	Council with the power to establish rules and procedures to regulate all meetings of						
3	the Council and its standing committees (Constitution of the Tohono O'odham Nation,						
4	Article VI, Section 1 (a)); and						
5	WHEREAS, the Legislative Council has exercised this power by adopting and amending the						
6	Legislative Rules of the Tohono O'odham Legislative Council ("Legislative Rules"),						
7	which include the process for submitting items to be placed on the Council's agendas;						
8	and						
9	WHEREAS, it is in the Legislative Council's best interest to amend Legislative Rules Article III, in						
10	accordance with the attached Legislative Rules amendments as dated for reference						
11	May 2013 in order to ensure that appointments of treasurer and other officers and						
12	heads of all governmental departments are appointed in a timely manner, to make the						
13	Council's process for reviewing appointments more uniform, and to ensure Council						
14	has adequate information to assess an appointee's qualifications and suitability for						
15	appointment.						
16	NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby adopts						
17	the Legislative Rules amendments as dated for reference May 2013, which shall now						
18	apply to appointments previously approved by the legislative Council.
