3	WHEREAS, the First Thing First initiative was passed by Arizona Voters in 2006 via proposition 203
4	which increases the quality and access to early childhood programs that will ensure
5	all Arizona children enter school healthy and ready to learn; and
6	WHEREAS, the Tohono O'odham Nation recognizes specific areas of need in the Division of Special
7	Needs to provide parent outreach and awareness; and
8	WHEREAS, the First Things First agreement stipulates the grantee may allocate up to 10% of the
9	direct cost for indirect cost; and
10	WHEREAS, the Health and Human Services Committee and the Budget & Finance Committee of
11	the Legislative Council have reviewed the budget in the amount of \$292,690.00 and
12	recommends its approval and adoption.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
14	approves:
15	1. The budget in the amount of \$292,690.00 for the period of July 1, 2013 to June 30,
16	2014.
17	2. Authorize 10% indirect cost allocation.
18	3. Authorization to utilize the Nation's resources pending reimbursement from the
19	Grantor for the continuation of the agreement.
20	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative council hereby authorizes
21	the Chairman and any designated official to expend and administer the budget as
22	attached, provided that any amendments affecting the funds or funding level will be
23	submitted for further prior approval by the Tohono O'odham Legislative Council.
