

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Department of Health and Human Services, Division of Family Assistance –
FY2014 Low Income Home Energy Assistance Program)

RESOLUTION NO. 13-193

1 WHEREAS, the Low Income Home Energy Assistance Program (LIHEAP) has been beneficial in
2 providing financial assistance to eligible low-income households in meeting utility
3 needs, i.e., electricity, propane, water and wood; and

4 WHEREAS, the allocation to the Tohono O'odham Nation for FY2014 through the State of Arizona,
5 Department of Economic Security, Division of Aging and Adult Services – Community
6 Action Program is \$62,572.00; and

7 WHEREAS, the Tohono O'odham Nation is hereby submitting the FY2014 budget for funding
8 through the State of Arizona, Department of Economic Security, Division of Aging and
9 Adult Services – Community Action Program in the amount of \$62,572.00 for contract
10 period July 01, 2013 through June 30, 2014; and

11 WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee
12 of the Legislative Council have reviewed this budget and recommend its approval and
13 adoption.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
15 authorizes the expenditure of the FY2014 Low Income Home Energy Assistance
16 Program (LIHEAP) budget in the amount of \$62,572.00 in accordance with the attached
17 budget and to utilize the Nation's resources pending reimbursement from the Grantor
18 for the continuation of this agreement.

19 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
20 Chairperson and any designated official to expend and administer the budget as
21 attached, provided that any amendments affecting the funds or funding level shall be
22 submitted for further prior approval by the Tohono O'odham Legislative Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day
24 of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;
25 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,
26 Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
27 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
28 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
29 Stat. 984).
