

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2014 -Title III B; Title III C-1; Title III C-2 and Title III E Program**  
**Budgets, July 1, 2013 through June 30, 2014)**

**RESOLUTION NO. 13-194**

1 **WHEREAS, the Tohono O'odham Nation has successfully operated the Senior Services program**  
2 **for the Elders of the Nation; and**

3 **WHEREAS, funding for period July 1, 2013 through June 30, 2014 for the operation of the Senior**  
4 **Services Program is possible in part by Title III of the Older Americans Act funds**  
5 **administered through the Inter-Tribal Council of Arizona (ITCA); and**

6 **WHEREAS, the funding is necessary to continue Nutrition, Socialization, Transportation and**  
7 **Home Delivered Meal services that are provided to eligible Elders. Also, to continue**  
8 **to provide caregiver support services to Caregivers of Elders and Elders raising**  
9 **Grandchildren; and**

10 **WHEREAS, the fiscal Year 2014 Title III-B \$46,546; Title III C-1 \$84,450.00; Title III C-2 \$45,230.00**  
11 **program budgets have been prepared for the Nutrition, Socialization, Transportation**  
12 **and Home Delivered Meal services for eligible Elders; and**

13 **WHEREAS, the fiscal Year 2014 Title III E \$29,613.00 budget has been prepared to provide support**  
14 **services to current and potential Caregivers who provide care services for Elders and**  
15 **to Elders who care for grandchildren; and**

16 **WHEREAS, the Health and Human Services Committee and Budget and Finance Committee of the**  
17 **Legislative Council has reviewed this budget amendment and recommends its**  
18 **approval and adoption.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
20 **approves:**

21 **The fiscal Year 2014 Title III-B \$46,546; Title III C-1 \$84,450.00; Title III C-2 \$45,230.00**  
22 **program budgets for the Nutrition, Socialization, Transportation and Home Delivered**  
23 **Meal services for eligible Elders; Title III E \$29,613.00 budget for support services to**  
24 **current and potential Caregivers who provide care services for Elders and to Elders**  
25 **who care for grandchildren and to utilize the Nation's resources pending**  
26 **reimbursement from the Grantor for the continuation of this agreement.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
28 **Chairperson and any designated official to expend and administer the budget as**  
29 **attached, provided that any amendments affecting the funds or funding level is**  
30 **submitted for further prior approval by the Tohono O'odham Legislative Council.**


