RESOLUTION NO. 13-195

1 **WHEREAS, the Tohono O'odham Nation successfully applied for and was awarded a five year**
2 **Grant from the U.S. Department of Health and Human Services, Centers for Disease**
3 **Control and Prevention (CDC) grant period June 30, 2012 – June 29, 2017; and**

4 **WHEREAS, the U.S. Department of Health and Human Services Centers for Disease Control and**
5 **Prevention (CDC) issued a Notice of Award on July 03, 2012 awarding grant funding for**
6 **the period covering June 30, 2012 through June 29, 2017, subject to the availability of**
7 **funds and satisfactory progress; and**

8 **WHEREAS, the Tohono O'odham Comprehensive Cancer Prevention and Control Planning grant**
9 **has submitted the FY 2014 Budget and proposal in the amount of \$230,135.10; and**

10 **WHEREAS, the Health and Human Services Committee and Budget & Finance of the Legislative**
11 **Council have reviewed this budget and recommends its approval and adoption.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**
13 **approves the FY 2014 Comprehensive Cancer Prevention and Control Planning Grant**
14 **budget in the amount of \$230,135.10 for the period covering June 30, 2013 through**
15 **June 29, 2014 and to utilize the Nation's resources pending reimbursement from the**
16 **Grantor for the continuation of this Grant.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the Budget as**
19 **attached, provided that any Amendments affecting the funds or funding level is**
20 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day**
22 **of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,**
24 **Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
25 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
26 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
