6	amount of \$30,974.34 and indirect cost charges in the amount of \$31,550.95; and
7	WHEREAS, the FY 2014 Division of Early Childhood Development has been reviewed by the Human
8	Resources Development Committee and Budget and Finance Committee and
9	recommend its approval and adoption.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
11	approves the FY 2014 Division of Early Childhood Development, in the amount of
12	\$349,810.75 and to utilize the Nation's Resources pending reimbursement from the
13	Grantor for the continuation of the Grant.
14	BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby authorizes
15	the Chairperson and any designated official to expend and administer the budget, as
16	attached, provided that any amendments affecting the funds or funding levels of the
17	budget shall be submitted for further prior approval by the Tohono O'odham Nation
18	Legislative Council.
