

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2014 First Things First)

RESOLUTION NO. 13-197

1 **WHEREAS, the First Things First Tohono O'odham Nation Regional Council has awarded funds to**
2 **the Division of Early Childhood Development; and**

3 **WHEREAS, the Tohono O'odham Nation through the Head Start Program has been successfully**
4 **providing services to eligible Tohono O'odham children and families; and**

5 **WHEREAS, the 2014 Budget reflects personnel in the amount \$287,285.46, operational in the**
6 **amount of \$30,974.34 and indirect cost charges in the amount of \$31,550.95; and**

7 **WHEREAS, the FY 2014 Division of Early Childhood Development has been reviewed by the Human**
8 **Resources Development Committee and Budget and Finance Committee and**
9 **recommend its approval and adoption.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
11 **approves the FY 2014 Division of Early Childhood Development, in the amount of**
12 **\$349,810.75 and to utilize the Nation's Resources pending reimbursement from the**
13 **Grantor for the continuation of the Grant.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Legislative Council hereby authorizes**
15 **the Chairperson and any designated official to expend and administer the budget, as**
16 **attached, provided that any amendments affecting the funds or funding levels of the**
17 **budget shall be submitted for further prior approval by the Tohono O'odham Nation**
18 **Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD Day**
20 **of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**
22 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
23 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
24 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
