

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting and Approving the Institute of Museum and Library Services Basic Library**  
**Services Grant, NG-05-12-0116-12, and the FY 2014 IMLS Basic Grant Budget)**

**RESOLUTION NO. 13-199**

1 **WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia**  
2 **Library, the primary library agency for the Tohono O'odham Nation; and**

3 **WHEREAS, the Venito Garcia Library is charged with library development for the Tohono**  
4 **O'odham Nation; and**

5 **WHEREAS, the Tohono O'odham Nation has applied for and received the Basic Library Services**  
6 **Grant from Institute of Museum and Library Services (IMLS), Native American Library**  
7 **Services (NALS) who is the primary library funding agency from the United States**  
8 **federal government; and**

9 **WHEREAS, the Venito Garcia Library is submitting an FY 2014 IMLS Basic Grant Budget in the**  
10 **amount of \$7,000.00; and**

11 **WHEREAS, IMLS does not allow for an Indirect Cost rate for these funds and will be waived; and**


12 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**  
13 **Committee of the Tohono O'odham Legislative Council have reviewed this budget and**  
14 **recommend its approval and adoption.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
16 **approve and accept the grant funds for the Venito Garcia Library from the Institute of**  
17 **Museum and Library Sciences (IMLS), Native American Library Services (NALS) in the**  
18 **amount of \$7,000.00 with no Indirect Cost rate.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairperson and any designated official to expend and administer the budget as**  
21 **attached, provided that any amendments affecting the funds or funding level is**  
22 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup> Day**  
24 **of MAY, 2013 at a meeting at which a quorum was present with a vote of 2,304.90 FOR; -0- AGAINST;**  
25 **-0- NOT VOTING; and 475.70[03] ABSENT, pursuant to the powers vested in the Council by Article**  
26 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
27 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
29 **Stat. 984).**




