## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Overriding Veto of Resolution No. 13-184, "Appointing Donald Harvey to the Tohono O'odham Judicial Court")

RESOLUTION NO. 13-202

1	WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative
2	Council with the power to appoint judges to the Tohono O'odham Judicial Court and
3	to adopt rules and procedures governing Council meetings and Council committees
4	(Constitution, Article VI, Section 1(a) and Article VIII, Section 3); and
5	WHEREAS, the Legislative Council has adopted procedures vesting the Legislative Judiciary
6	Committee with authority to interview, evaluate, and recommend qualified
7	individuals to serve on the Judicial Court bench, and the Committee has
8	recommended qualified candidates for appointment, including Nation's member
9	Donald Harvey; and
10	WHEREAS, on May 22, 2013, the Tohono O'odham Legislative Council passed Resolution No. 13-
11	184, "Appointing Donald Harvey to the Tohono O'odham Judicial Court"; and
12	WHEREAS, pursuant to Article VII, Section 5 of the Nation's Constitution,
13	Every law, ordinance, resolution or separate appropriation item passed by the Tohono
14	O'odham Council shall be presented to the chairman for his approval before it
15	becomes effective. If he approves, he shall sign it. But if he disapproves, he shall
16	return it to the Tohono O'odham Council within forty-eight (48) hours, with his
17	objections. If after consideration, it again passes the council by a majority of two-
18	thirds (2/3) of the votes cast, it shall become law and he shall sign it notwithstanding
19	his objections.
20	WHEREAS, on May 30, 2013, the Nation's Chairman vetoed Resolution No. 13-184; and
21	WHEREAS, pursuant to Article IX, Sections 2(B) and (C) of the Legislative Rules of the Tohono
22	O'odham Legislative Council, vetoed legislation shall be placed on the agenda of the
23	next legislative session and shall have priority over all other items; and
24	WHEREAS, the Council Chairman has called an emergency session to address vetoed legislation.
25	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
26	overrides the veto of Resolution No. 13-184, "Appointing Donald Harvey to the Tohono
27	O'odham Judicial Court."
28 29 30 31 32 33	The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the <u>04<sup>TH</sup></u> day of <u>IUNE, 2013</u> at a meeting at which a quorum was present, and by a vote of <u>2,780.60</u> FOR; <u>-0-AGAINST;-0-NOT VOTING</u> ; and <u>[03] ABSENT</u> , was passed by a vote of two-thirds (2/3) <u>[1,853.73]</u> of the votes cast as required by Article V, Section 1; Article VI, Section 5; and Article VIII, Section 3 of the Constitution of the Tohono O'Odham Nation.
