

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Apportionment of District Votes on the Tohono O'odham Legislative Council)

LEGISLATIVE ORDER NO. 13-206

1 **WHEREAS, Article V, Section 2 of the Constitution of the Tohono O'odham Nation provides that**
2 **votes cast by Legislative Council representatives shall be apportioned as follows:**

3 **Each district shall be entitled to as many votes on the Tohono**
4 **O'odham Council (divided by ten) as there are members of the**
5 **Tohono O'odham Nation residing in the district. Such votes may**
6 **be cast by either or both of the district representatives, or their**
7 **alternates, who are present and voting.**

9 **WHEREAS, on Saturday, May 25, 2013 the Tohono O'odham Election Board conducted a general**
10 **election for the offices of chairperson of the Hia-Ced District, vice-chairperson of the**
11 **Hia-Ced District, and representatives and alternates to the Tohono O'odham**
12 **Legislative Council and district councils; and**

13 **WHEREAS, following the general election, the Election Board issued and posted its Certificate of**
14 **Election Results (Uniform Election Ordinance, Article VII, Section 6.K.); and**

15 **WHEREAS, the Election Board certified and posted its Certification of District Residents, entitled**
16 **"Certification of District Votes," dated May 25, 2013, which is incorporated by this**
17 **reference, apportioning the number of votes each district is entitled to cast on the**
18 **Tohono O'odham Legislative Council (Uniform Election Ordinance Article VII, Section**
19 **1.B.1(B)); and**

20 **WHEREAS, the number of Legislative Council votes apportioned and certified by the Election**
21 **Board in its "Certification of District Votes" totals 2,946.5; and**

22 **WHEREAS, the five-day period for appealing the number of votes given to each district by the**
23 **Election Board has expired and no such appeal has been filed.**

24 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council accepts the**
25 **apportionment of votes each district is entitled to cast on the Tohono O'odham Legislative Council**
26 **in accordance with the "Certification of District Votes" dated May 25, 2013, attached hereto.**

27 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12TH day of**
28 **JUNE, 2013 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; ~~0~~ AGAINST;**
29 **~~0~~ NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article V,**
30 **Section 2; Article VI, Section 1 (g) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Ac**
33 **t of June 18, 1934 (48 Stat. 984).**


