| 12 | Legislative Council and district councils; and |
| 13 | WHEREAS, following the general election, the Election Board issued and posted its Certificate of |
| 14 | Election Results (Uniform Election Ordinance, Article VII, Section 6.K.); and |
| 15 | WHEREAS, the Election Board certified and posted its Certification of District Residents, entitled |
| 16 | "Certification of District Votes," dated May 25, 2013, which is incorporated by this |
| 17 | reference, apportioning the number of votes each district is entitled to cast on the |
| 18 | Tohono O'odham Legislative Council (Uniform Election Ordinance Article VII, Section |
| 19 | 1.B.1(B)); and |
| 20 | WHEREAS, the number of Legislative Council votes apportioned and certified by the Election |
| 21 | Board in its "Certification of District Votes" totals 2,946.5; and |
| 22 | WHEREAS, the five-day period for appealing the number of votes given to each district by the |
| 23 | Election Board has expired and no such appeal has been filed. |
| 24 | NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council accepts the |
