

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Selection of Evonne Wilson as Legislative Council Secretary)

LEGISLATIVE ORDER NO. 13-210

1 WHEREAS, the Constitution of the Tohono O'odham Nation authorizes the Legislative Council to
2 "select from outside of its own membership a secretary" to "serve until replaced by the
3 council" (Constitution, Article V, Section 5); and


4 WHEREAS, Evonne Wilson previously was selected and currently serves as the Legislative Council
5 Secretary pursuant to Legislative Orders No. 09-121, No. 09-323, and No. 11-226; and

6 WHEREAS, if she is again selected, Evonne Wilson will serve as the Legislative Council Secretary
7 until replaced by the Legislative Council in accordance with the Nation's Constitution.

8 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it
9 selects and appoints Evonne Wilson as the Legislative Council Secretary; provided that
10 she shall serve until replaced by the Legislative Council.

11 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12TH day of
12 JUNE, 2013 at a meeting at which a quorum was present with a vote of 2,946.0 FOR; -0- AGAINST; -0-
13 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article V, Section
14 5 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
15 January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
16 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
