

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Designating July 12, 2013 General Session for an Update and Tour of the
Tohono O'odham Gaming Enterprise)

LEGISLATIVE ORDER NO. 13-219

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**
4 **Section 1(a)); and**

5 **WHEREAS, Article I, Section 2(C) of the Legislative Rules of the Tohono O'odham Legislative**
6 **Council, as amended, provides that "[a]ll Legislative Council sessions shall be held at**
7 **the Tohono O'odham Legislative Council chambers located in Sells, Tohono O'odham**
8 **Nation, with the following exceptions. . . [a] majority of all the legislative**
9 **representatives may vote to hold a session in some location other than the chambers**
10 **located at Sells."; and**

11 **WHEREAS, the Commerce Committee has requested the Legislative Council designate July 12,**
12 **2013 general session for an update and tour of the Tohono O'odham Gaming**
13 **Enterprise at the Desert Diamond Casino and Hotel location with roll call beginning**
14 **at 9 a.m.**

15 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it designates**
16 **July 12, 2013 general session for an update and tour of the Tohono O'odham Gaming**
17 **Enterprise at the Desert Diamond Casino and Hotel location with roll call beginning**
18 **at 9 a.m.**

19 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13TH day of**
20 **JUNE, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR;-0- AGAINST; -0-**
21 **NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section**
22 **1 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation**
23 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
24 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
