RESOLUTION NO. 13-220

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws and**
2 **ordinances governing the enrollment and adoption of members (Article II, Sections**
3 **1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation);**
4 **and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the Enrollment**
6 **Committee is responsible for reviewing enrollment applications and making**
7 **recommendations to the Legislative Council regarding the eligibility of applicants**
8 **(Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
10 **applicants for membership contain misspellings in the names of applicants; or**
11 **incorrect roll numbers; and**

12 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 37-80, 114-80,**
13 **127-83, 197-83, 138-87, 142-89, 93-443, 96-004, 95-415, 95-518, 96-26, 97-105, 97-221, 97-**
14 **144, 97-350, 98-034, 98-123, 98-461, 99-200, 99-311, 99-360, 99-475, 99-633, 2000-035, 01-**
15 **004, 01-094, 01-449, 02-280, 04-350, 07-075, 09-008, 11-459 and 12-386 be amended to**
16 **reflect the correct name spelling or roll numbers for the individuals identified in the**
17 **Amending Enrollment Resolution List June 2013, which is incorporated by this**
18 **reference; and**

19 **WHEREAS, the Enrollment Program has further determined that two members were erroneously**
20 **approved twice for membership (one member was originally approved by Resolution**
21 **No. 97-480 and the second member was originally approved by Resolution No. 04-508);**
22 **and**

23 **WHEREAS, the Enrollment Program discovered that these same two members were approved a**
24 **second time in Resolution Nos. 98-123 and 07-075; and**

25 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 98-123 and 07-**
26 **075 be amended to delete the members identified in the Amending Enrollment**
27 **Resolution List June 2013; and**

17 **Section 1 and Section 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham**
18 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
19 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
20 **of the Act of June 18, 1934(48 Stat. 984).**
