

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting 2013-2015 Legislative Council Committee Meeting Schedule)**

LEGISLATIVE ORDER NO. 13-222

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**
2 **and procedures to regulate all meetings of the . . . standing committees" (Constitution,**
3 **Article VI, Section 1(a)); and**

4 **WHEREAS, "the legislative committees of the Legislative Council are the standing committees of**
5 **the Legislative Branch performing continuing functions for an indefinite time, whose**
6 **membership shall consist of representatives to the Legislative Council." (Legislative**
7 **Rules of the Tohono O'odham Legislative Council, Article XI, Section 1(A)(1)); and**


8 **WHEREAS, on June 12, 2013, following the election of Chairperson, Vice-Chairperson, and**
9 **selection of Secretary, the Tohono O'odham Legislative Council elected committee**
10 **members and officers to the Council's 12 standing committees; and**

11 **WHEREAS, the Legislative Rules Committee has drafted a schedule listing regular Legislative**
12 **Council committee meetings for 2013-2015.**

13 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it adopts the**
14 **"2013-2015 Legislative Council Committee Meeting Schedule," which is dated for**
15 **reference June 2013 and which shall remain in effect until committee memberships**
16 **are elected following the Nation's 2015 general election.**

17 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13TH day of**
18 **JUNE, 2013 at a meeting at which a quorum was present with a vote of 2,705.5 FOR; -0- AGAINST; -0-**
19 **NOT VOTING; and 241.0[04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
20 **Section 1 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
21 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
22 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
