and Children (WIC) – ITCA Budget Amendment #1, to adjust award
from \$185,625.00 to \$201,600.00, Account 650-13-6261")

RESOLUTION NO. 13-225

1 **WHEREAS, the Tohono O'odham Nation has successfully operated the Tohono O'odham**
2 **Department of Health and Human Services-Division of Community Health-Women**
3 **Infants and Children (WIC) Program which provides preventive health care; and**

4 **WHEREAS, the Inter-Tribal Council of Arizona through an Intergovernmental Agreement receives**
5 **funds from the United States Department of Agriculture for programs designed to**
6 **benefit women, infants and children; and**

7 **WHEREAS, the Tohono O'odham Nation has entered into a Memorandum of Agreement with the**
8 **Inter-Tribal Council of Arizona to fund and operate the Women, Infants, and Children**
9 **(WIC) Program for time period October 01, 2012 through September 30, 2015; and**

10 **WHEREAS, the services provided to eligible clients have been beneficial and services continue to**
11 **be necessary to help alleviate nutritional health risks and improve the health of**
12 **individuals at risk; and**

13 **WHEREAS, the Inter Tribal Council of Arizona is increasing grant level from \$185,625.00 to**
14 **\$201,600.00 for the Women, Infant and Children (WIC) program effective October 1,**
15 **2012; and**

16 **WHEREAS, the FY 2013 WIC – ITCA Budget Amendment #1 increase to Indirect Costs from**
17 **\$29,242.91 to \$31,217.24; and**

18 **WHEREAS, the following line items are increased : 7000 Office Supplies, 7010 Program Supplies,**
19 **7020 Kitchen Supplies, 7100 Utilities, 7410 RM Vehicles and 7430 RM Grounds, also**
20 **creating line items: 6530 Transportation and 7210 Freight/Postage; and**

21 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
22 **of the Legislative Council have reviewed this Budget and recommend its approval and**
23 **adoption.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 25 **1. Approves FY 2013 Women, Infant and Children, (WIC) – ITCA Budget Amendment**
26 **#1 adjusting grant award amount from \$185,625.00 to a new award amount of**
27 **\$201,600.00.**
- 28 **2. Approves increases to operational expense line items.**
- 29 **3. Approves creating new lines to the Women, Infant and Children (WIC) ITCA budget.**
- 30 **4. Approves an increase to Indirect Cost from \$29,242.91 to \$31,217.24.**

7 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,**
8 **Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
9 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
10 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
11 **Stat. 984).**




