4	in an institution or another setting; and
5	WHEREAS, the original 2013 budget did not include sufficient funds in the GSA Vehicle Lease line
6	item 7220 to cover monthly expenses for the program GSA vehicles; and
7	WHEREAS, the attached budget amendment was prepared to decrease operational expense line
8	items in order to increase line item 7220 – GSA Vehicle Lease; and
9	WHEREAS, the IDC rate also decreased from 18.82% to 18.43%; and
10	WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee
11	of the Legislative Council have reviewed this Budget amendment and recommend its
12	approval and adoption.
13	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
14	approves the Adult Care Services Program FY2013 Budget Amendment #1 decreasing
15	operational expense line items to increase line item 7220- GSA Vehicle Lease and to
16	change IDC rate from 18.82% to 18.43%.
17	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
18	Chairperson and any designated official to expend and administer the budget as
19	attached, provided that any amendments affecting the funds or funding level is
20	submitted for further prior approval by the Tohono O'odham Legislative Council.
