6	amount of \$232,772.72; and
7	WHEREAS, this budget amendment will increase the original budget of \$120,247.98 to a revised
8	amount of \$353,020.70 and will also increase the overall district's FY 2013 budget of
9	\$1,846,534.95 to a revised amount of \$2,079,307.67; and
10	WHEREAS, after review and discussion the Tohono O'odham Legislative Council approves the FY
11	2013 budget amendment #1 for South Komelic Community utilizing identified FY 2000
12	to FY 2010 carryovers in the amount of \$232,772.72.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council reviewed,
14	discussed and approved the South Komelic Community's FY 2013 budget amendment
15	#1 to increase their line items as identified in the attached budget, utilizing identified
16	FY 2000 to FY 2010 carryovers in the amount of \$232,772.72.
17	BE IT FURTHER RESOLVED that this budget amendment #1 will increase South Komelic
18	Community original FY 2013 budget amount of \$120,247.98 to a revised amount of
19	\$353,020.70 and will increase the overall district's FY 2013 budget of \$1,846,534.95 to
20	a revised amount of \$2,079,307.67.
