

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Fiscal Year 2013 Cowlic Community Budget Amendment #2)**

1 **WHEREAS, Sells District, Cowlic Community Resolution No. CC-114-12; Sells District Council**
2 **Resolution No. SD-107-12 and Tohono O'odham Legislative Council Resolution No. 13-**
3 **015 approved Sells District, Cowlic Community Fiscal Year 2013 Budget Amendment**
4 **#1; and**

5 **WHEREAS, Cowlic Community has identified the need to further amend their Fiscal Year 2013**
6 **Budget to address additional needs of the community; and**

7 **WHEREAS, Cowlic Community has prepared and acquired approvals of the attached budget**
8 **amendment and it's justifications with Cowlic Community Resolution No. CC-29-13**
9 **and with Sells District Council Resolution No. SD-52-13; and**

10 **WHEREAS, this amendment will increase line items #6510 Lodging by \$1,500.00; #7060 Food by**
11 **\$2,000.00; #7615 Donation/Contribution by \$4,000.00 and #7610 Clothing Allowance**
12 **by \$500.00; and**

13 **WHEREAS, this amendment will also decrease line items #6530 Travel Expense by \$500.00; #7010**
14 **Program Supplies by \$500.00; #7020 Supplies – Kitchen by \$1,500.00; #7400 RM**
15 **Equipment by \$1,000.00; #7065 Consumables by \$1,000.00; #6700 Awards by \$500.00;**
16 **and #7500 Major Capital Equipment by \$3,000.00; and**

17 **WHEREAS, Cowlic Community Budget Amendment #2 increases and decreases line items with a**
18 **total amount of \$8,000.00.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves Sells**
20 **District, Cowlic Community Fiscal Year 2013 Budget Amendment #2 of the Gaming**
21 **Revenues by increasing line items #6510 Lodging by \$1,500.00; #7060 Food by \$2,000.00;**
22 **#7615 Donation/Contribution by \$4,000.00 and #7610 Clothing Allowance by \$500.00**
23 **and decreasing line items #6530 Travel Expense by \$500.00; #7010 Program Supplies**
24 **by \$500.00; #7020 Supplies – Kitchen by \$1,500.00; #7400 RM Equipment by \$1,000.00;**
25 **#7065 Consumables by \$1,000.00; #6700 Awards by \$500.00; and #7500 Major Capital**
26 **Equipment by \$3,000.00 for a total amount of \$8,000.00.**

27 **BE IT FURTHER RESOLVED that this amendment does not affect the approved Cowlic Community**
28 **FY 2013 Budget of \$75,000.00 or the overall Sells District Fiscal Year 2013 budgeted**
29 **amount of \$1,512,757.74.**

30 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
31 **District Chairperson and any designated District Official to expend and administer the**
32 **budget as attached, provided that any modifications or amendments affecting the**

O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
