

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY2013 Pisinemo District Administration Modification/Amendment No. 1
in the Amount of \$28,100.00 and Adding Additional Language to R&M Building and
Salary Justification)**

RESOLUTION NO. 13-233

1 **WHEREAS, the Tohono O'odham Legislative Council and Budget & Finance Committee has**
2 **reviewed a proposal from Pisinemo District Administration to modify and amend its**
3 **FY 2013 operating budget; and**

4 **WHEREAS, the modification will deduct various amounts from Line Items #610-Salaries, 640-Per**
5 **Diems, 720-Office Supplies, 751-Lease and Rental, and 778-Renovation and Alterations**
6 **for a total amount of \$28,100.00 to increase Line Items #620-Fringe Benefits, 630-**
7 **Insurance, 710-Utilities, 711-Telephone, 771-R&M Vehicle in the total amount of**
8 **\$28,100.00; and**

9 **WHEREAS, the amendment will include changing the number of summer youth workers from 10**
10 **to 11 position's; and**

11 **WHEREAS, the R&M Building Justification will include additional wording to read (may also be**
12 **used for community home exterminations).**

13 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council approves the request**
14 **from Pisinemo District Administration to modify and amend its FY2013 Operating**
15 **Budget in the amount of \$28,100.00 and include additional wording to budget**
16 **justifications for line items: R&M Building and Salaries.**

17 **BE IT FURTHER RESOLVED THAT the Tohono O'odham Legislative Council hereby authorizes the**
18 **District Chairperson and any designated officials to expend and administer the budget**
19 **as attached, provided that any amendments affecting the funds or funding level be**
20 **submitted for further prior approval by the Tohono O'odham Legislative/District**
21 **Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
23 **of JUNE, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Article VI,**
25 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
