8	WHEREAS,	one of the main priorities of the Legislative Council is to foster, support, and
9		encourage the health, safety, and general well-being of the Nation's children and
10		youth; and
11	WHEREAS,	the Administration for Children and Families ("ACF") provides a number of grants,
12		programs, and services, including but not limited to domestic violence prevention,
13		child support enforcement, Head Start, child care, and other resources; and
14	WHEREAS,	the ACF is seeking nominations for its new Tribal Advisory Committee "to assist and
15		provide advice to the Assistant Secretary for Children and Families " (March 8, 2013
16		ACF letter); and
17	WHEREAS,	it is in the best interest of the Tohono O'odham Nation and its members to nominate

19		Advisory Committee either as a representative from Region IX or as a member at-
20		large; and
21	WHEREAS,	the Nation previously nominated Representative Grace Manuel to the ACF Tribal

23		and Human Services Committee (Resolution No. 13-161); and
24	WHEREAS,	the Health and Human Services Committee recommends nominating Representative
25		Loretta Lewis to the ACF Tribal Advisory Committee as a representative from Region
26	ı	IX or a member at-large with Representative Adam Andrews as her alternate.
27	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it nominates
28		Representative Loretta Lewis to the ACFT ribal Advisory Committee as a representative
29		from Region IX or a member at-large with Representative Adam Andrews as her
