4		authority to "consult, negotiate and conclude agreements and contracts on behalf of
5		the Tohono O'odham Nation with Federal, State and local governments and other
6		Indian tribeswithin the authority of the Tohono O'odham Council." (Constitution,
7	:	Article VI, Section 1(c)(2) and Section 1(f)); and
8	WHEREAS,	the Special Diabetes Programs for Indians ("SDPI") was created by Congress to address
9		the disproportionate impact of diabetes in American Indian and Alaska Native
10		communities; and
11	WHEREAS,	the Tribal Leaders Diabetes Committee ("TLDC") was created by the Indian Health
12		Services ("IHS") Director as an advisory committee in matters related to the SDPI and
13		to make recommendations for the improvement of diabetes care and prevention
14		among American Indian and Alaska Native people; and
15	WHEREAS,	the TLDC is comprised of one tribal leader and one tribal alternate from each of the
16		12 IHS Area Offices and are generally tribal elected officials selected by their
17		respective tribe to serve on the TLDC; and
18	WHEREAS,	since 1997, representatives of the Tohono O'odham Nation have served on the TLDC
19		from the Tucson Area, including most recently Representative Grace Manuel and
20		Representative Frances Antone as her alternate; and
21	WHEREAS,	Representative Grace Manuel and Representative Frances Antone no longer serve on
22		the Health and Human Services Committee; and
23	WHEREAS,	it is in the best interest of the Tohono O'odham Nation to appoint a Legislative Council
24		Health and Human Services Committee member as the TLDC Tucson Area
25		representative and an alternate; and
26		the Health and Human Services Committee recommends appointing Representative
27		Adam Andrews as the TLDC Tucson Area representative and Representative Diana
28		Manuel as the alternate.

30		(1) Appoints Representative Adam Andrews as the TLDC Tucson Area representative
