RESOLUTION NO. 13-243

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws and**
2 **ordinances governing the enrollment and adoption of members (Article II, Sections**
3 **1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation);**
4 **and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the Enrollment**
6 **Committee is responsible for reviewing enrollment applications and making**
7 **recommendations to the Legislative Council regarding the eligibility of applicants**
8 **(Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
10 **applicants for membership contain misspellings in the names of applicants; or**
11 **incorrect roll numbers and**

12 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 138-81, 127-83,**
13 **164-83, 95-484, 95-555, 96-035, 96-224, 96-260, 96-514, 97-105, 97-144, 97-256, 97-322,**
14 **97-460, 98-123, 98-429, 98-492, 99-004, 99-039, 99-080, 99-475, 99-633, 2000-035, 2000-**
15 **083, 2000-397, 01-496, 01-589, 02-003, 07-657 and 11-158 be amended to reflect the**
16 **correct name spelling or roll numbers for the individuals identified in the Amending**
17 **Enrollment Resolution List July 2013, which is incorporated by this reference; and**

18 **WHEREAS, the Enrollment Program has further determined that a member was erroneously**
19 **approved twice for membership (member was originally approved by Resolution No.**
20 **99-004); and**

21 **WHEREAS, the Enrollment Program discovered that this same member was approved a second**
22 **time in Resolution Nos. 10-070; and**

23 **WHEREAS, the Enrollment Program therefore recommends that Resolution No. 10-070 be**
24 **amended to delete the member identified in the Amending Enrollment Resolution List**
25 **July 2013; and**

26 **WHEREAS, the member who was originally approved in Resolution No. 99-004 will retain the roll**
27 **number and approval date identified in that original resolution.**

9 is amended upon effective date of that resolution by deleting the member and
10 corresponding information identified in the Amending Enrollment Resolution List
11 July 2013.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day
13 of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0- AGAINST;
14 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article II,
15 Section 1 and Section 2 and Article VI, Section 1 (h) of the Constitution of the Tohono O'odham
16 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
17 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
18 of the Act of June 18, 1934 (48 Stat. 984).


