12	for and on behalf of the Pima County Forensic Science Center, substantially in the
13	form attached hereto, and authorizes the Chairman of the Nation to execute it.
14	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council approves amendments to
15	extend the term of the Intergovernmental Agreement, provided that amendments for
16	any other purpose shall be presented to the Legislative Council for review and
17	approval.
