

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Intergovernmental Agreement between Pima County, for and on behalf
of the Pima County Forensic Science Center, and the Tohono O'odham Nation for
Medical Examiner Services)

RESOLUTION NO. 13-250

1 **WHEREAS, the Tohono O'odham Nation Police Department seeks to have the Nation enter into an**
2 **Intergovernmental Agreement with the Pima County, for and on behalf of the Pima**
3 **County Forensic Science Center; and**

4 **WHEREAS, the Pima County has a Forensic Science Center established and is willing to provide**
5 **medical examination services to the Tohono O'odham Nation; and**

6 **WHEREAS, the physicians employed by Pima County as medical examiners will provide medical**
7 **examination services for the Tohono O'odham Nation; and**


8 **WHEREAS, the Domestic Affairs Committee has reviewed the Intergovernmental Agreement and**
9 **recommends its approval.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
11 **Intergovernmental Agreement between the Tohono O'odham Nation and Pima County,**
12 **for and on behalf of the Pima County Forensic Science Center, substantially in the**
13 **form attached hereto, and authorizes the Chairman of the Nation to execute it.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council approves amendments to**
15 **extend the term of the Intergovernmental Agreement, provided that amendments for**
16 **any other purpose shall be presented to the Legislative Council for review and**
17 **approval.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
19 **of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0- AGAINST;**
20 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,**
21 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


