

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting the 2013-2018 Intergovernmental Agreement with the Arizona Department of
Economic Security for the Title XX Budget)

RESOLUTION NO. 13-256

1 WHEREAS, the Tohono O'odham Nation provides services to improve the availability,
2 affordability and quality of child care through funding provided by the Arizona
3 Department of Economic Security's Planned Social Services Block Grant (S.S.B.G.) Title
4 XX Program; and

5 WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its young
6 members by providing for their welfare through various programs and services
7 designed to meet their special needs; and

8 WHEREAS, the Arizona Department of Economic Security has negotiated an Intergovernmental
9 Agreement for a five (5) year term, with the Arizona Department of Economic Security
10 for Planned Social Services Title XX Block Grant for the period of July 1, 2013 through
11 June 30, 2018, in the amount of \$105,088.00 per year; and

12 WHEREAS, the Inter-Governmental Agreement has been reviewed and approved by the Human
13 Resources Development Committee and the Budget & Finance Committee of the
14 Legislative Council and each recommend its approval and adoption by the Legislative
15 Council.

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
17 approve the Arizona Department of Economic Security Planned Social Services Title
18 XX Intergovernmental Agreement substantially in the form attached hereto, and
19 further authorizes the Chairman to execute it.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day
21 of JULY, 2013 at a meeting at which a quorum was present with a vote of 2,946.5 FOR; -0- AGAINST;
22 -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,
23 Section 1 (f) & (I) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
24 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
26 Stat. 984).
