

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Tohono O'odham Department of Health and Human Services, Division  
of Behavioral Health, Youth Suicide Prevention Grant for FY 2014)**

**RESOLUTION NO. 13-258**

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health provides**  
2 **substance abuse, mental health, and prevention services; and**

3 **WHEREAS, the Tohono O'odham Nation submitted an application to the U.S. Department of**  
4 **Health and Human Services/Substance Abuse and Mental Health Services**  
5 **Administration (USDHHS/SAMHSA) for a Youth Suicide Prevention Grant Initiative to**  
6 **provide programs to reduce youth suicides and increase wellness due to high**  
7 **incidence of youth suicide on the Nation; and**

8 **WHEREAS, the Tohono O'odham Nation received a Notice of Award from USDHHS Tribal Youth**  
9 **Suicide Prevention Grant Initiative number 1U79SM060417-01 for three year award**  
10 **period effective August 1, 2011 through July 31, 2014; and**

11 **WHEREAS, the budget represents the third year of the three year grant effective August 1, 2013**  
12 **through July 31, 2014, has been developed in the amount of \$479,999.88; and**

13 **WHEREAS, the Health & Human Services Committee and Budget and Finance Committee of the**  
14 **Legislative Council have reviewed this budget and recommended its approval and**  
15 **adoption.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 17 **1. Approve the Tribal Youth Suicide Grant Initiative from 1U79SM060417-01**  
18 **DHHS/SAMHSA in the amount of \$ 479,999.88 for the period of August 1, 2013 to July**  
19 **31, 2014.**
- 20 **2. Hereby approves and authorizes expenditures in accordance with FY 2014, Youth**  
21 **Suicide Prevention Grant Initiative and attached budget in the amount of**  
22 **\$479,999.88 for the third year of a three year grant.**
- 23 **3. To utilize the Nation's resources pending reimbursement from the Grantor for the**  
24 **continuation of this Grant.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairperson and any designated official to expend and administer the budget as**  
27 **attached, provided that any amendments affecting the funds or funding level is**  
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**






