10	period effective August 1, 2011 through July 31, 2014; and
11	WHEREAS, the budget represents the third year of the three year grant effective August 1, 2013
12	through July 31, 2014, has been developed in the amount of \$479,999.88; and
13	WHEREAS, the Health & Human Services Committee and Budget and Finance Committee of the
14	Legislative Council have reviewed this budget and recommended its approval and
15	adoption.

21	Suicide Prevention Grant Initiative and attached budget in the amount of
22	\$479,999.88 for the third year of a three year grant.
23	3. To utilize the Nation's resources pending reimbursement from the Grantor for the
24	continuation of this Grant.
